Right to Counsel in Evictions (HB18)

- ♦ Sen. Hettleman Senate Judicial Proceedings
- ♦ Del. Fisher House Judiciary
 - ♦ Income eligible tenants would have right to a lawyer in any eviction case, including subsidy terminations, illegal lock-outs, and "constructive evictions" (uninhabitability)
 - ♦ Est. "Right to Counsel Fund" and RTC Taskforce
 - ♦ Implement by 2025 across Maryland

Access to Counsel in Evictions (HB18)

- ♦ Income eligible tenants would have *access* to a lawyer in any eviction case, including subsidy terminations, illegal lock-outs, and "constructive evictions" (uninhabitability)
- ♦ Est. "*Access* to Counsel Fund" and ATC Taskforce
- ♦ Try to implement by 2025 across Maryland
- ♦ No certain funding mechanism
- ♦ TBD: Signed/Vetoed by Governor?

Pre-Litigation Eviction Notice

- ♦ Lease Non-renewal/Expiration: increased notice period from 30 days to 60 days (SB 401)
- Failure to Pay Rent: est. 10-day notice and cure period before landlord can file "FTPR" eviction action in court.
 - Notice that rent is late, amount is due within 10 days, legal and financial resources, mediation and Help Center info
 - Instead of starting litigation on 6th of month, many actors will wait until 16th: increased likelihood of pre-trial payment
